This family was first taxed in the South Precinct of DC about 1740 but two brothers were in Beekman as early as 1739. A John Calkins was in Pawling for the 1790 census. The emigrant was HUGH CALKINS who was born ca. 1600 and was of Norwich, CT by 1640. He m. Ann ____ and died 1690. We have decided to follow two lines because we are unsure of the exact identity of the man in the 1790 census.

He seems to have owed money to Henry Livingston for we find that on 8 Oct. 1746 he and his brother John Calkin, doctor, posted an appearance bond of £11/4. The condition of the bond was that Jeremiah would answer charges brought by Livingston that he refused to pay him £5/2. He was the subject of legal actions in the following: AD 440, 447, 450, 501, 506, 529, 613, 1601, 1655, 1885, 2011.

- 4. JOHN⁴ CALKINS, (John³⁻², Hugh¹) was born in Lebanon, CT 19 November 1699 and m. there as John Calkins 3rd 9 April 1721, Sarah, dau. of Samuel and Mary (Clark) Huntington. He was taxed as John 3rd in the South Precinct of DC by June 1747 and was taxed through 1748 and again from Feb. 1758, with 'estate' in June 1759 to Feb. 1760. He was probably the John Calkins who had many legal actions in DC. [AD 454, 685, 1653, 1655, 1719, etc.].

He was the John Calkins who was one of the men who induced Samuel Terry to preach in Beekman ca. 1739 and according to AD 1768 was living in Beekman at the time. Terry sued him and his brother Jeremiah for not living up to the contract.
