Fifthly I do give unto my son Josiah Swift this house & land I now live in & possess excepting yt peice of Land about ye peket Clifts I bought of Jonat Mory.

Sixthly, I do give unto ye three sons of William Swift my son deceased Thos Swift Josiah Swift and Ebenezer Swift that tract of Land I bought of Jonat Mory Lying upon the Clifts as ye goe to Plymouth as appears by a deed equally to be divided among the three brothers, and not to be sold or anyways to be disposed of but to the Swifts

7th I do give unto my son Jirah Swift twenty pounds in movables of my estate. 8ly I do give unto my Grandson William Swift Son to ye deceased Wm Swift twenty shillings.
