

Lemuel SNOW of Barnstable MA to **Reuben FISH** of same. <Barnstable Co.Deeds 4:197;73:243>

...28 July 1814, Lemuel SNOW, yeoman, for \$20.00 sold to Reuben FISH, yeoman...one quarter of 12 acre meadow in Barnstable...bounded by land of Joseph PARKER, Ebenezer CROCKER and heirs of Shubal HAMBLIN & Simeon JENKINS. Wf Lydia SNOW releases dower. Witnesses: Jabez HOWLAND, Daniel PARKER. Ack. 21 July 1814. Rec. 7 Sept. 1814.

Lemuel SNOW of Barnstable MA to **David PARKER** of same. <Barnstable Co.Deeds 4:215;73:141>

...9 Feb. 1814, Lemuel SNOW, yeoman, for \$1500.00 sold to David PARKER, yeoman...all my homestead lands, partly cleared & partly woodland, in Barnstable on each side the Country road called Fal-mouth road & contains 60 acres...with my dwelling house...which I purchased of Joseph HOWLAND, David HOWLAND, Jonathan HOWLAND & Rachel JENKINS as per their several deeds...reserving to my self...until the last day of September next liberty to take off the corn that shall grow on the land the ensuing season & if by reason of sickness or other casualty I shall be hindred from removing my family I reserve the use of the buildings & a privilege to cut fire wood until the first of May 1815. Witnesses: David SCUDDER, Joseph PARKER. Ack. same day. Rec. 26 Mar. 1814.

Silas BLISH of Barnstable MA to **Lemuel SNOW** of same. <Barnstable Co.Deeds 4:257>

...21 Mar. 1791, Silas BLISH, yeoman, for £9.12s sold to Lemuel SNOW, yeoman...one half of salt meadow in Barnstable lying in common & undivided with Elisha BLISH who owns the other half...the whole piece contains a sufficient quantity of meadow to cut nine tons of hay yearly...bounded by land of Ebenezer BLISH, Deacon Ebenezer HAMBLIN, Joseph BLISH & Silvanus HINCKLEY...also one half of an Island of thatch ground...reserving to Jane Ewer widow of John EWER...the use & improvement of half...the same meadow I bought of Hezekiah MARCHANT Jr. & Jonathan EWER. Witnesses: Ebenezer BACON, Peter WHILDEN. Wf Chloe BLISH releases dower. Ack. & Rec. 21 Mar. 1791.

Elisha BLISH of Barnstable MA to **Lemuel SNOW** of same. <Barnstable Co.Deeds 4:252;44:202>

...1 Sept. 1791, Elisha BLISH, yeoman, for £11 sold to Lemuel SNOW, yeoman...one half of eight acre salt meadow in Barnstable...in common & undivided with the sd Lemuel who owns the other half...bounded northerly by the Harbour and land of Ebenezer BLISH, Deacon Ebenezer HAMBLIN, Joseph BLISH & Silvanus HINCKLEY...also one half of an Island of Thatch ground...being in common with the sd Lemuel...reserving to Jane EWER widow of John EWER late of Barnstable dec'd, the use & improvement of half...and is the same meadow I bought of Hezekiah MARCHANT & Jonathan EWER. Wf Rebecca BLISH releases dower. Witnesses: David HAMBLIN, Reliance HAMBLIN. Ack. 30 Mar. 1792 by Elisha. Rec. 30 Mar. 1792.

Solomon HINCKLEY of Barnstable MA to **Lemuel SNOW** of same. <Barnstable Co.Deeds 4:218;47:207>

...3 Apr. 1795, Solomon HINCKLEY, yeoman, for £8.19s5d sold to Lemuel SNOW, yeoman...three & a half acre wood land in Barnstable adjoining sd Lemuel's land...bounded by land of Robinson T. HINCKLEY & John HINCKLEY. Wf Mercy HINCKLEY releases dower. Witnesses: Robinson T. HINCKLEY, Ebenezer BACON. Ack. same day. Rec. 6 Apr. 1795.

Joseph PARKER of Barnstable MA to **Lemuel SNOW** of same. <Barnstable Co.Deeds 5:105;66:20>

...18 Mar. 1809, Joseph PARKER, yeoman, for \$125.00 sold to Lemuel SNOW, yeoman...three & a half acres in Barnstable in a place called the Timber-land...bounded by land of Asa NYE, Capt. John CROCKER & Daniel PARKER. Wf Mehitable PARKER releases dower. Witnesses: Joseph SNOW, Hercules SNOW. Ack. 8 May 1809 by Joseph. Rec. 26 May 1809.

Isaac HODGES of Barnstable MA to **Isaac BEARSE** et al of same. <Barnstable Co.Deeds 1:133>

...26 Apr. 1802, Isaac HODGES, gent., for \$1282.00 sold to Isaac BEARSE, James BEARSE & Lemuel BEARSE, yeomen...land in Barnstable incl. dwelling house & homestead lands. Wf Lydia HODGES releases dower.

Hercules HODGES & Isaac HODGES of Barnstable MA to **Isaac BEARSE** et al. <Barnstable Co.Deeds

<2:184;57:213>...26 Apr. 1802, Hercules HODGES, mariner & Isaac HODGES, gent., for \$60.00 sold to Isaac BEARSE, James BEARSE & Lemuel BEARSE, all of Barnstable...two acres in Barnstable...bounded by road leading from Phinneys lane and land of Thomas LEWIS, sd BEARSES and Prince LUMBARD. Wives Lydia HODGES & Lydia HODGES release dowers. Witnesses: David SCUDDER, Moses STURGIS. Ack. same day by grantors.

Isaac HODGES of Barnstable MA to **Isaac EWER** of Nantucket. <Barnstable Co.Deeds 1:182>

...26 Feb. 1818, Isaac HODGES, gent., for \$1500.00 sold to Isaac EWER, housewright...a certain piece of land all that I purchased of Peter CAMMET, five acres more or less with the dwelling house thereon that I now live in...

Isaac HODGES of Barnstable MA to **Benjamin F. CROCKER** of same. <Barnstable Co.Deeds 4:270;78:167>

...20 June 1818, Isaac HODGES, ship carpenter, for \$250.00 sold to Benjamin F. CROCKER...one half of salt works standing on south side of Barnstable and are the same that we bought of Capt. Nehemiah LOVELL. Wf Lydia HEDGE/HODGES releases dower. Witnesses: Josiah SAMPSON, Lucy HODGES. Ack. 24 June 1818 by Isaac & Lucy. Rec. 27 June 1818.

Isaac HODGES & Benjamin HADAWAY of Barnstable MA to **Eli HINCKLEY** of same. <Barnstable Co.Deeds

<2:162;79:232>...28 June 1819, Isaac HODGES & Benjamin HADAWAY, gentlemen, for \$13.00 sold to Eli HINCKLEY, cordwainer...two pieces of cedar swamp in Barnstable...bounded by land of David CHASE, Abner HINCKLEY & others, Silvanus HINCKLEY, Benjamin KILLEY, Levi KILLEY and Elisha BLISH. Witnesses: Lydia HODGES, Silvanus HINCKLEY, Benjamin F. HADAWAY, Mary Ann HADAWAY. Ack. 13 July 1819 by Benjamin. Rec. 23 Aug. 1819.
