

WILL OF HUMPHERY BARRETT KENT COUNTY F-1-14

August 11th 1726 The will and testament of Humphery Barrett being weak in body but sound in memory after all my just debts and funeral charges is paid

Item I give to my well beloved wife **Pheby** Barrett all my personal estate and also leave to my wife all my lands and possessions during her life and if my wife should see fit or cause to sell to any person fifty acres of land at the head next to Joshua Clayton ye she shall have full power at her own discretion soto do yt she shall make sale as fully as if I my self were presentable I leave to my two sons Humphery & William all the remainder of my lands to be divided according to my wifes and her brother David Morgans discretion and of bdth or either of them should prove disobedient them I also leave my wife at her own disscression to give it to any two of the rest of my sons and also I leave my well beloved wife my whole and sole Ext.

Register aforesaid was proved approved and insinuated the last will and testament of Humphery Barrett to these presents annexed having whilst he lived and at the time of his death divers goods rights and credits and more especially in the said County of Kent by means whereof the approbation and insinuation of the said last will and testament and committing the admr of all and singular the goods rights and credits of the said dec'd and also the auditing the accts. calculations and reconings of the said admr. and a final dismission from the same to meare manifestly known to belong and admr of all and singular the goods rights and credits any wise concerning the said dec'd and his last will and testament was committed to Pheby Barrett the Exx. therein named they being first attested according to Law will and faithfully to administer the same and a full and faithful Inventory of all and singular the goods rights and credits of the said dec'd to make and duly exhibit and also a plain and true acct. calculation and reckoning thereof to render into the Register office for the County of Kent aforesaid when thereunto leagually required. In Testimony whereof I have caused the seal of my said office (which in this behalf I use) to be affixed to these presents at Dover aforesaid this twenty fourth day of August in the twelfth year of the Reign of our Soveriegh Lord George over Great Britian Anno Domo 1726
